 - 2. Motion to approve bylaws, moved; bylaws approved.
 - b. Treasurer Jeff Hicks
 - i. In the middle of reconciling September but there is a general fund after moving 5K money over of \$7298.00
- 5. School Board representative report Yasmina Bouraoui
 - a. School board election in November with three positions open.
 - i. "Meet the Candidates" night sponsored by District Parent Council, Thursday, October 27, 7:00pm at MacDonald Middle School
 - ii. There was one held by the League of Women Voters last week and there will be another hone hosted by the Glencairn Neighborhood Association. Information on that will be emailed to Joy by Yasmina.
 - b. There is a bond committee that meets every week and they are open to the public; their chair invited the board to come and listen.
 - i. Recommendations will be wrapped up before Thanksgiving and the board will be looking at the recommendations and will be looking to vote for that before May due to bond restrictions.
 - 1. Building wouldn't start for a couple years Yasmina will send a schedule out.
 - ii. There were two great presentations on learning spaces made by teachers at the last meeting.
 - 1. Lots of places to move, and are more student centered
 - 2. Community space could serve if there are volunteers that come
 - 3. There were designated places for STEAM
 - 4. Community gardens

- iii. Early Childhood Presentations
 - 1. They suggested two pods in two elementary schools with a long list of what would be ideal.
 - 2. A central shared space with other spaces off of that and that could flow in and out.
 - 3. There would be different payment models so it would be accessible to everyone.
- c. A motion to rename Columbus Day was made at the recent Board meeting, proposing that Indigenous People's Day be recognized. Discussion arose of how this might impact curriculum.
- 1. It brought up more issues so this will be revisited at a later date d. There were issues with class sizes brought up and that created some tension.
 - i. In this year's contract it was very clear what the class sizes would be before there would be financial considerations made.
 - 1. Administration is going to deal with this issue and try and establish some criteria to use
- e. Angle Smith asked whether the number of special needs children (and thus their para pro assistants) in a given classroom is balanced with other classrooms in the same school in order to limit the number of adults in a class.
 - 1. Yasmina said she would look into that.

 - ii. There were 2 police officers and the normal 2 crossing guards and it worked fine there was no re-routing that happened.
 - iii. All kids got to participate, even if they weren't able to walk to school, with the perimeter walk after the bell rang.
 - iv. Hawk's Nest was able to be dropped off at the church on Towar and then walked from there to the school.
 - 1. There were more than 35 children that walked from the bus start to school.
 - v. It might be helpful to publicize the parade even more beforehand so kids know where to go and late children aren't confused.
